BSNP Logo Revealed

The new logo for Blue Springs Nature Preserve was unveiled at the Sept. 5 Steering Committee meeting. The logo is influenced by

a prominent water oak, estimated to be over 100 years old and found in the preserve's prairies.

"It never did grow too tall, always expanding its limbs in an uneven pattern," said Charlie Brannon, who grew up on the land. "It was always in the way when we mowed the fields beside it. My dad wanted to cut it down, but my mother thought it was so unique, she would not let him."

In addition to the tree, the logo was designed to incorporate various elements of the site, including the hillside and stream.

BSNP Plans Come Together

Now that Huntsville-based land-planning firm 4Site, Inc. has finalized the master plan for Blue Springs Nature Preserve, a clear vision for the project is in place.

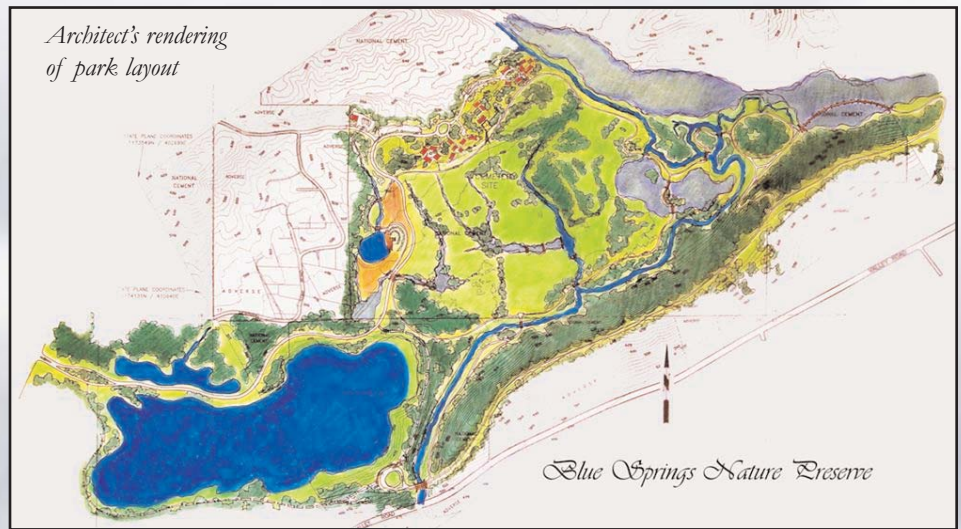
In 2006, a charrette was conducted with the Blue Springs Nature Preserve Steering Committee to develop a master plan for Blue Springs. The resulting plan, presented to the Steering Committee on Sept. 5, proposes the following features:

Highway 144 Entrance - This site will be a dedicated access point to Blue Springs, with a parking lot and transportation by tram into Blue Springs.

Alabama Wildflower Gardens - Located near an old farm pond, an outdoor arboretum showcases native plants, such as the endangered Alabama Leatherflower.

A visitor center will include a weather-protected exhibit space, a greenhouse, public restrooms, and an outdoor gathering space for self-guided tours.

Cultural Preservation Building - Visitors can relive the history of St. Clair County through artifacts and exhibits, such as a cotton gin from the Civil War Era.



Spencer's Bluff - An elevated knoll overlooking the lake near the tram route, this feature provides an optimum location for picnics and resting, with a covered pavilion, restrooms and drinking fountains.

Visitor's Facilities - Atop the knoll along the ridge line rest the principal buildings, such as the education center, administrative offices and classrooms.

Prairie, Wildflower and Ridge areas - Visitors can explore Blue Springs through a network of trails, which provide access to scenic overlooks and streamside greenways, as well as wetlands

and prairies, restored to their original state.

Trout Creek Crossing - A boardwalk provides an up-close view of the rivers and wetlands, an ideal venue for first-hand outdoor education.

Primitive Campgrounds - In the preserve's wooded areas, visitors have the opportunity to camp in a rustic setting.

Future phases include a dormitory, kitchen facilities and a conference center.

A public unveiling of the plans for Blue Springs Nature Preserve is expected later this fall.



Did You Know? BSNP is a Butterfly Sanctuary

The Monarch butterfly is the official state insect of Alabama. During last year's charrette, participants witnessed a large rabble of monarch butterflies. According to representatives of 4Site, Inc., the Blue Springs Nature Preserve is within the flightpath of the migrating butterflies, who stopped over to sample the site's goldenrod flower population.

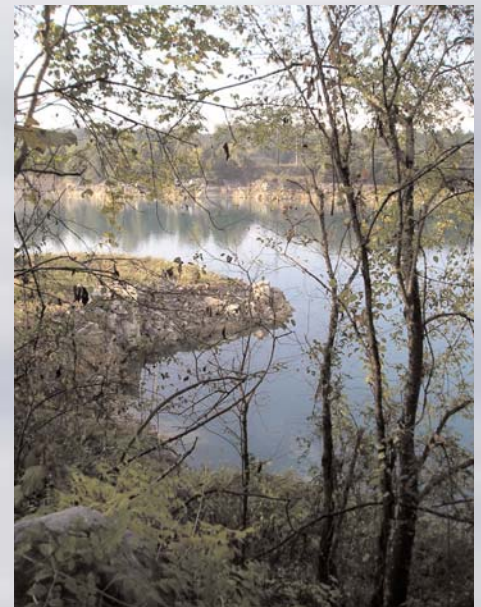
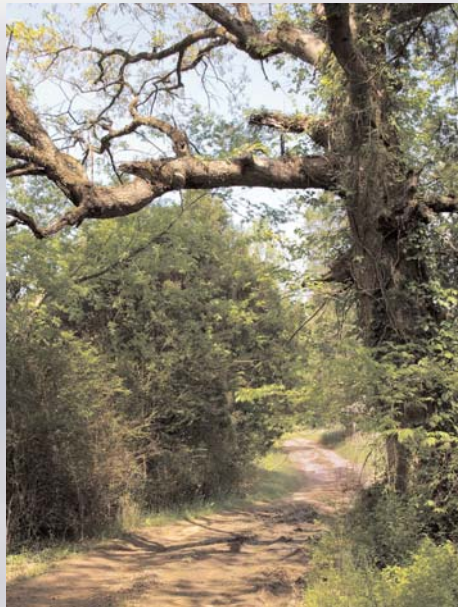
